- REQUIRED:**
1. **Application (attached)**
 2. **Surety Bond Letter**
 - Current Date
 - Company's bonding capability/capacity/limits/rates, etc.
 - Surety Company's AM Best Rating & Treasury Limitations
 3. **Reviewed / Audited Financials**
 - Most current's fiscal year-ended
 - Balance Sheet (Assets, Liabilities, Retained Earnings, & Stockholder's Equity)
 - Income Statement (Contract Revenue Earned and Operating Profit)
 4. **Project Backlog Worksheet (attached)**

ALL BACK-UP PAPERWORK MUST BE SUBMITTED TO BE ELIGIBLE FOR BID LIST PLACEMENT

UPON RECEIPT: Your Completed Application (& back-up paperwork) is sent off to our Pre-qualification Review Board, to determine bid list placement approval status. You'll be notified before they are complete, if: (1) Additional info is required; (2) Required paperwork was missing.

You will receive final notification after you've completed the interview. Once all paperwork has been accepted, you'll be notified if you've been placed on our interview schedule and should await contact from a PENTA interviewer. All companies will receive their final bid list placement approval notification, via email, (to identified company contacts); and if approved, information on working with PENTA on upcoming job opportunities!
